Subject:-Status of University of Patanjali – regarding.

Sir,

With reference to your mail dated 14.03.2021 on the subject cited above, I am directed to inform you that the University of Patanjali, Patanjali Yogpeeth, Haridwar, Uttarakhand has been established by an **Act No.4 of 2006** of State Legislature of Uttarakhand as a Private University and is empowered to award degrees as specified under Section 22 of the UGC Act to the students studying in its main campus in regular mode with the approval of Statutory Bodies/Councils, wherever it is required, after creating required academic and physical infrastructure facilities including library, laboratories and appointment of teaching and supporting staff as per the norms and standards laid down by UGC and other relevant Statutory Council(s). The name of University has been included in the list of Universities established as per Section 2(f) of UGC Act, 1956. A copy of letter of number even dated May, 2010 is also enclosed.

University of Patanjali, Uttarakhand is not authorized to open study centre/ off campus centre beyond the territorial jurisdiction of the state as per the judgment of Hon'ble Supreme Court of India in case of Prof. Yashpal vs. State of Chhattisgarh. The University cannot open its centre(s) even within the state as per the provision of UGC (Establishment of and Maintenance of Standards in Private Universities) Regulations, 2003 without the approval of UGC.

The UGC has not granted any approval to the University to open off campus/study centre.

No University, whether Central, State, Private or Deemed can offer its programme through franchising arrangement with Private coaching institutions even for the purpose of conducting courses through distance mode.

Sir,

With reference to your letter No. PWV/2010/195 dated 15<sup>th</sup> May, 2010 on the above subject, I am directed to say that the University of Patanjali, Hardwar (Uttarakhand) a Private University has been established by an Act (No. 04 of 2006 amended in 2009) of State Legislature of Uttarakhand as a State Private University and is empowered to award degrees as specified by the UGC under section 22 of the UGC Act 1956 through its main campus and with the approval of statutory bodies/Councils, wherever required.

There is no provision to affiliate Colleges/have Regional Centres and off Campus Centers beyond the territorial jurisdiction of the State as per the judgment of the Hon'ble Supreme Court of India in the case of Prof. Yash Pal Vs State of Chhattisgarh.

Keeping in view of the above, you are requested to ensure the following:-

1. No off campus centre(s) is opened by the University outside the territorial jurisdiction of the State in view of the judgement of Hon'ble Supreme Court of India in case of Prof. Yash Pal Vs State of Chhattisgarh.
2. In case the University has already started any off campus centre outside the State, it must be closed immediately. It may also be ensured that any off campus centre within the State shall be opened only as per the provision laid down in the UGC (Establishment of and maintenance at standards in Private University) Regulation 2003 and with the prior approval of UGC.
3. The University shall not have any affiliate College.

The University is required to follow the UGC (Establishment of and Maintenance of Standards in Private University) Regulations, 2003 (copy enclosed).

You are also requested to send the information in the prescribed format (copy enclosed) for inspection purpose as per UGC Regulation referred to above within a one month from the date of receipt of this letter.
